

HC quashes nomination of Kodandaram and Amer Ali Khan

The Telangana High Court on Thursday quashed Governor Tamilisai Soundararajan's rejection orders of the nomination of Dasoju Sravan Kumar, Kurra Satyanarayana by the previous BRS government to MLC posts and. It also quashed the nomination orders of Prof Kodandaram and Amer Ali Khan along with the Gazette notification issued by the Governor.

A Division Bench, comprising Chief Justice Alok Aradhe and Justice Anil Kumar Jukanti, passed orders to this effect while dealing with a couple of writ pleas filed by Sravan Kumar and Satyanarayana challenging the action of the Governor in rejecting the proposals of the previous BRS government to nominate the two as members of the Legislative Council. The petitioners contended that the Governor was not empowered to reject the said What the HC said

 Governor has power to remit the matter to Council of Ministers either to furnish requisite documents/information or for reconsideration of the recommendation made by the Council of Ministers

 Governor is not answerable to the court in view of Article 361 of the Constitution. No positive direction can be issued to the



proposals as per Articles 163 and 171 of the Constitution.

Even as the court was hearing the matter, the new Congress government had recommended the appointment of Prof Kodandaram and Amer Ali Khan to MLC posts, with the Governor accepting the proposal and issuing a Gazette notification on January 27, appointing them. When the petitioners filed another writ plea chal-

lenging such appointments during the pendency of their writ petition as arbitrary and unconstitutional, the Bench stayed the swearingin of Kodandaram and Amer Ali. The Advocate General, arguing on behalf of the government, said the petitioners did not have locus standi to seek implementation of the then government's recommendations nominating them.



departments, Telangana has experienced an average rainfall of 914.90 mm until Wednesday, surpassing the normal of 866.40 mm by 5.4 per cent. Thus, the State received more-than-normal rainfall, which is calculated based on the average rainfall that occurred over a long period of 30-35 years.

The actual rainfall that occurred in a year is compared with normal rainfall to categorise it as large excess (60 per cent and above), excess (20-59 per cent), normal (19 to -19 per cent), deficit (-20 to -59 per cent) and large deficit (-60 to -99 per cent).

CM lays stone for elevated corridor

Months after assuming power in the State, Chief Minister A Revanth Reddy on Thursday showed that he was yet to get over the habit of blaming the previous government for almost everything and claiming credit for the work done by the previous regime.

Hyd artist sketches B'luru blast suspect

Hyderabad-based artist Dr Harrsha Samudrala has made sketches of the suspect of Bengaluru's Rameshwaram Cafe blast, based on an image put out by the National Investigation Agency (NIA) on Wednesday.

Dr Harrsha, a professional artist, posted the images on his social media handles on

Police and the Bengaluru Commissioner of Police to help the investigation as the suspect has been elusive since the blast took place on March 1.

Speaking to *Telangana Today*, he said he was in Bengaluru attending a programme on the day of the blast and learnt about the incident while he was still in

"I got to know about the screengrab of the CCTV
