Kejriwal issues 1st order from jail

Directs Atishi to resolve water and sewage issues in Delhi

IANS NEW DELHI

In the midst of discussions regarding his ability to perform duties as the Delhi Chief Minister while in Enforcement Directorate's (ED) custody, Arvind Kejriwal issued an order on Sunday, his first one from the custody.

The directive pertained to the water supply of the na-tional capital, and it was conveyed by the Chief Minister through a memoran-dum to Delhi Minister Atishi, who oversees the concerned portfolio. "I have come to know that there are significant issues with water and sewage in some areas of Delhi. I am concerned about this. Since I am in jail, people should not face any inconvenience because of this. Summer is also approaching," read Chief Minister Kejriwal's letter in Hindi.

Atishi said Kejriwal, despite being in custody, was more concerned about the people of the national capital than himself. "Arvind Kejriwal, while in ED custody, has sent directives to me as the Water Minister to promptly address the water and sewage issues faced by Delhiites and arrange for an adequate number of water tankers during the summer," she said. "When I read these directives, tears welled up in my eyes. I wondered what



I.N.D.I.A bloc's rally on March 31

kind of person he is, who amidst such adverse circumstances, isn't thinking about himself but about the people of Delhi," she said.

The ED has taken cognisance of Atishi's statement that Kejriwal sent her directions from the agency's custody, official sources said. It will conduct an investigation to ascertain if these directions were in line with the special PMLA court's order issued to the ED and Kejriwal during his custody, the sources said.

Meanwhile, Supreme Court lawyer Vineet Jindal wrote to L-G VK Saxena terming the directions a "gross violation of legal procedures". "Standard legal procedures dictate that any individual in remand cannot engage in communication with the outside world without court approval," he (SEE PAGE 2)

KTR warns YT channels against spreading lies

BRS working president KT Rama Rao on Sunday said conspiracies were being hatched to defame the party through lies being spread by YouTube channels. He warned that legal action would be initiated against such channels for acting ir-

responsibly. YouTube channels were expected to work responsibly. However, in the garb of disseminating news, a few YouTube channels were spreading falsehoods without any evidence and re-peatedly sharing false news. Further, they put up thumbnails for such news to mislead people, he said.

"These illegal videos and false news are being propagated due to sheer opposition towards the BRS or due to the money offered by the ruling party. This is a conspiracy to defame our party, personally me," Rama Rao

said on X. All these attempts were being made to mislead the people and confuse them. Legal action has been initiated against a few channels and media organisations, which published false propaganda against the party in the past, he said.

Similarly, the nefarious and conspiratorial attempts being made by a few YouTube channels currently would be faced legally, he added.

"We will also register defamation cases and take criminal action against YouTube channels that propagate falsehoods and spread propaganda in the name of news with illogical thumbnails," Rama Rao

Ex-IAF chief joins BJP

Pak for trade ties with India

ISLAMABAD

Pakistan will "seriously" consider restoring trade ties with India that remained suspended since August 2019, Foreign Minister Muhammad Ishaq Dar has said, indicating a potential shift in diplomatic stance towards the nation.

Dar made these remarks during a press conference in London following his par-ticipation in the Nuclear Energy Summit in Brussels, Geo News reported. He highlighted the eagerness of cash-strapped Pakistan's business community to resume trade activities with

India. "Pakistani businessmen want trade with India to resume," the Foreign Minister said on Saturday. Pakistan will consider

restoring trade ties with India, he said. "We will seriously look into matters of trade with India," Dar was quoted as saying by the Express Tribune newspaper.

His remarks indicated a potential shift in diplomatic stance towards India. Pakistan downgraded its ties with New Delhi after the Indian government abrogated Article 370, revoking the special status of J&K and bifurcating the State into two (SEE PAGE 2)

Case politically motivated: Santosh

Stating that a forgery case was booked against him with political malice and to defame the BRS, Rajya Sabha MP Joginpally San-tosh Kumar said he had pur-chased 904 square yards in Survey No. 129/54 of Shaikpet eight years ago in

Based on a complaint by a representative of Navayuga Company on Thursday, the police booked a case against the MP. The company claimed it had purchased 1,350 square yards in Survey No. 129/54 and complained that the land was encroached upon.

Reacting sharply, the MP said he had purchased the 904 square-yard house site from Shyamsundar Fuljal, son of PV Hanumanth Rao,

on November 11, 2016, through sale deed number 5917/2016. The asset was purchased legally for Rs 3.81 crore and the sale deed was executed by the Registration Department.

"Since the last eight years, there is no litigation and no one approached me. There is no scope for any forgery at all," Santosh Kumar categorically stated.

Shyamsundar had purchased the house site in 1992 through sale deed number 1888/1992. There were no litigations involving the house site for the last 32 years. Even after purchasing the house site from Shyamsunder, no new constructions were taken up in the land. The structures that constructed by Shyamsunder and the earlier owners were still intact,

Parents in a fix over Class I admissions

arents looking to admit their wards in Class I for the 2024-25 academic year face a perplexing situation with two different policies for admissions in schools in the State.

The Kendriya Vidyalayas, Jawahar Navodaya Vidyalayas, other private schools affiliated with the CBSE and international boards have already embraced the National Education Policy (NEP) 2020 and switched to the minimum six-year age criterion for Class I admissions However, State Board schools are still following the age-old rule of a minimum of five years for Class I admissions.

Panel formed

A three-member committee, constituted by the Education Department to study the NEP provisions, has recommended a minimum of six years for Class I admission besides bring-

ing Pl, P2 and P3, and Classes I and II under Bala Vatikas. If the minimum six-year age criterion is to be implemented, the government should amend the GO 5 and 20 that mandate five years of age for Class I admissions in the State.

"As education is in concurrent list, it is the prerogative of the State government whether or not to implement NEP. Anyway, this will be discussed with the State government and a decision will be taken," a senior official said.

IIT student on way to join ISIS held

GUWAHATI

An IIT-Guwahati student, who allegedly pledged allegiance to ISIS and was on his way to join the terror group, was detained.

The student was nabbed in Hajo near Guwahati on Saturday evening. His apprehension comes four days after ISIS India head Haris Farooqi alias Harish Ajmal Farukhi and his associate Anurag Singh alias Rehan were arrested in Dhubri district after they crossed over

from Bangladesh. "Reference @IITGuwahati student pledging allegiance to ISIS — the said student has been detained while travelling and further lawful follow up would take place," Director General of Police GP Singh posted on X on Saturday.

Additional Superintendent of Police (STF) Kalyan Kumar Pathak said, "After receiving an email, we got about to verify the authenticity of the contents and started an investigation." PTI
