Cong questions 6% difference between provisional, final figures

Madhya Pradesh Congress Committee media in-charge Mukesh Nayak on Thursday raised doubts on the increase in final voting percentage of the first two phases of Lok Sabha polls saying there was a difference of six per cent between the provisional figures and exact figures given by the Election Commission.

Nayak said that it had never happened in history till date that the ECI took so long to release the exact voting percentage and that the ECI should clarify. "There is a difference of six per cent between the provisional fig**How turnout increased after** 11 days, asks Sanjay Raut

MUMBAI: Sena (UBT) MP Sanjay Raut questioned the ECI about the increase in the voting percentages of Phase I and Phase 2 polls and asked how it suddenly shot up after so many days. The hourly and daily voting percentages, provided on the Maharashtra Chief Electoral Officer and ECI websites were the latest current data. "However, after 11 days from Phase I and a week after the Phase 2 polling, ECI released the voting percentages which are much higher than the live data given on the polling dates. Where did the extra votes come from?" demanded Raut. (SEE PAGE 2)

The odds were against them when the Lok Sabha battle was announced, but now, the Bharat Rashtra Samithi appears to be fast gaining ground as the big day on May 13 approaches, courtesy its top three names leading from the front and turning the tables in favour of the party.

Earlier, soon after the Assembly debacle, the party found itself in a crisis, with not just senior leaders slanting towards parties in power, but also five of the nine MPs that the party sent to the Lok Sabha in 2019 deserting it. However, showing critics that he might have been down temporarily but certainly not out, founder president K Chandrashekhar Rao came out all guns blazing, brushing off the predicted impact of the deserters, who in his words were like sunflowers, turning towards where the sun (power) was.

What started with his 'Polam Bata', visiting unseasonal rain-hit farmers and those who lost crops due to the State government's failure to ensure irrigation water on time, took the form of 'Poru Bata' as Chandrashekhar Rao took to the streets with his bus tour,

Fake video: TPCC members may be summoned again

NEW DELHI

The Delhi Police is likely to serve a second notice to the members of the Telangana Congress in connection with the uploading and sharing a fake video of union Home Minister Amit Shah, the officials said on Thursday. The four members of the

Telangana Congress, who were supposed to appear before the office of the Intelligence Fusion and Strategic Operations, did not come on Wednesday. "We will again ask them to appear before the IO (investigating officer), as they did not come on Wednesday," an officer, privy to the investigation said.

The summonses were issued to Telangana Chief Minister A Revanth Reddy and four Telangana Pradesh Congress Committee (TPCC) members — Shiva Kumar Ambala, Asma Tasleem, Satish Manne and Naveen Pettem — under sections 91 and 160 of the Code of Criminal Procedure (CrPC). According to police sources, if a person is served notice under section 160/91 of the CrPC, the person can either make a physical appearance before the IO or send a legal represen-

tative. On Wednesday, Reddy's lawyer appeared before the IO and asserted that the Congress leader had noth-

Delhi Police team in Hvd

NEW DELHI: In its ongoing probe into Home Minister Amit Shah's doctored video case, a team of Delhi Police's Special Cell on Thursday visited Gandhi Bhavan in Hyderabad, sources said.

The sources also said the team met the local police and sought details about a few leaders, who were served notices. Meanwhile. the investigators are yet to receive any response from social media giants X and Meta in connection with the doctored video, a source in Delhi Police's Special Cell said. Three persons have been arrested for circulating the fake video so far. IANS

KTR calls EC BJP's 'shadow agency'

BRS working president KT Rama Rao on Thursday came down heavily on the Election Commission of India (ECI), stating that it was functioning under the influence of the BJP and failing to address complaints against Prime Minister Narendra Modi and union Home Minister Amit Shah for their divisive remarks.

He also questioned the ECI's inaction on complaints against Chief Minister A Revanth Reddy in Telangana for his abusive remarks and also for stifling the voices of Opposition leaders by filing false cases against them. Speaking at a media conference here at Telangana Bhavan, Rama Rao minced no words in categorically terming the ECI's action as "biased and selec-

tive". He said the ECI had turned a blind eye to inflammatory statements made by Modi and Shah, despite receiving around 20,000 complaints from citizens.

"I have no hesitation in stating that the Election Commission is acting like a shadow agency of the BJP. They are so scared to initiate action against Prime Minister Modi that they choose to issue notices to BJP national president JP Nadda for the inflammatory speech by Modi," he siad.

Shaksgam Valley ours, **MEA to China**

NEW DELHI

India has lodged a strong protest with China for carrying out construction activities in the Shaksgam Valley, in an "illegal" attempt to alter the situation on the ground. Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal said on Thursday that the Shaksgam valley is a part of India and New Delhi never accepted the so-called China-Pakistan boundary pact of 1963 through which Islamabad "unlawfully" attempted to cede the area to Beijing.

"We have consistently conveyed our rejection of the same. We have registered our protest with Chinese side against illegal attempts to alter facts on the ground," Jaiswal said. PTI
