Says 48-hour ban an attempt by political opponents to stifle his voice

Leader of Opposition and BRS president K Chandrashekhar Rao has spoken out against the Election Commission of India (ECI) and his political adversaries, questioning the recent ban on his poll campaign. The former Chief Minister accused the EC of bias, terming it as an attempt by the political opponents to stifle his voice, which was raised on behalf of the people of Telangana.

After the 48-hour ban imposed by the EC, the former Chief Minister addressed a massive rally in Ramagundam at around 9 pm on Friday. As people welcomed him with slogans of "CM, CM, CM", he thanked them for their support. Accusing both the Congress and the BJP of colluding, he asserted that the people have recognised their efforts to obstruct his poll campaign which was getting a rousing welcome.

He questioned the reason behind the 48-hour ban on his voice. He clarified that his use of strong language against a Congress leader, who suggested weavers sell 'Nirodh' and 'papads', was a result of anger over the State government's delay in clearing pending bills for the weavers.

Questioning the EC's double standards, Chandrashekhar Rao criticised its inaction against Union

Home Minister Amit Shah using religious imagery in election rallies for electoral gain and Prime Minister

Narendra Modi's divisive remarks promoting the Hindu-Muslim divide. He also cited comments by Chief Minister A Revanth Reddy as evidence of the EC's selective enforcement of Model Code of Conduct.

"Notwithstanding all these attempts, people will ultimately decide the electoral outcome," he said, exuding confidence in their judgment despite the challenges posed to him. Turn-

ing to the State's current challenges, the BRS supremo questioned the ruling party's accountability for the water and power crisis, particularly in the Peddapalli district where thousands of acres of crops have withered. He criticised the Congress for failing to fulfil its election promises and accused the Chief Minister of swearing in the name of God to deceive the people once again. (RELATED REPORT PAGE 4)

HD Revanna booked for kidnap

MYSURU: Karnataka Police registered an FIR against former Prime Minister HD Deve Gowda's son, JD(S) MLA HD Revanna in connection with the kidnapping of one of the victims in the sex video scandal involving his son Prajwal Revanna. The son of one of the victims has filed a police complaint over the abduction of his mother and named HD Revanna as the prime accused in the case. HD Revanna's relative Sathish Babu has been named as the second accused in the FIR. JANS

Karnataka Chief Minister Siddaramaiah on Friday said a rape case was booked against JD(S) leader and NDA's Hassan candidate Prajwal Revanna. Siddaramaiah said he directed police to identify, trace and secure the victims in view of the alleged kidnapping of a victim at Krishnaraja Nagar town in Mysuru district.

The mother of three children was allegedly abducted by Holenarsipura MLA and Prajwal's father HD Revanna and his confidant Sathish Babanna from her home after her 20-year-old son complained to the police. He said videos showed that his mother was allegedly tied and raped by Prajwal Revanna. Police have arrested Sathish Babanna and are interrogating him in connection with the case, a police source said. The Chief

Iran releases Indian crew members

NEW DELHI

Iran has said it released all the crew members of the Portuguese-flagged cargo vessel MSC Arius which had 17 Indians among its 25 crews. Iranian Foreign Minister Amir Abdollahian mentioned the release of the crew of the ship during a phone conversation with his Estonian counterpart Mar-

gus Tsahkna on Friday. "In response to the request of the Estonian side regarding the ship seized in the territorial waters of the Islamic Republic of Iran, Amir Abdollahian said the ship, which turned off its radar in territorial waters of Iran and endangered the security of navigation, is detained under judicial rules," Iranian Foreign Ministry said. Kerala, TN coasts on swell surge alert

Hyderabad-based Indian National Centre for Ocean Information Services (INCOIS) issued a swell surge warning to Kerala, south Tamil Nadu, Lakshadweep, and Andaman & Nicobar Island for May 4 and 5. This marks the first time a red alert has been issued for the phenomenon by the INCOIS and the National Disaster Management Authority (NDMA) in this part of the country.

INCOIS, under the Ministry of Earth Sciences (MoES), forecast the possibility of swell surges and rough sea conditions associated with the effect of high-period swell waves that were approaching from the distant southern Indian Ocean.

The event started at approximately 10,000 km away from the Indian coast on April 26 in the southern Atlantic Ocean and slowly moved towards the Southern Indian Ocean around April 28. (SEE PAGE 2)

Rahul files papers from Raebareli

Congress leader Rahul Gandhi filed his papers from Uttar Pradesh's Raebareli constituency on Friday, barely an hour before nominations closed for the Lok Sabha seat.

Earlier, in the morning, the Congress ended the suspense over Amethi and Raebareli, announcing his candidature from the seat held by his mother Sonia Gandhi for the last two decades. She recently moved to the Rajya Sabha.

Gandhi had lost from the adjoining Amethi constituency to BJP's Smriti Irani in 2019 but won from Wayanad in Kerala - a seat he is contesting this time as well. The former Congress president was accompanied by party leaders Mallikarjun Kharge, Sonia Gandhi and Priyanka Gandhi Vadra as he handed over his papers to district election officer Harshita Mathur around 2 pm on the last day for filing nominations. A study carried out by the University of Hyderabad (UoH) scientists demonstrated the health benefits of the 'king of the fruits' and said consuming mangoes

turned out to be a remedy for most gastrointestinal problems.

Key nutrients

In addition to several key nutrients such as Vitamin A, Vitamin B6 and Vitamin C, which may help boost the body's natural immune system, mangoes contain a combination of polyphenols and fibre that have shown to improve gut health and relieve constipation.

Mangiferin, a xanthone C-glucoside found in several plant species, including mangoes, is well known for its pharmacological properties. This organic compound is found in higher concentration in the leaves, and peels than in the pulp in various types of mangoes.

Several scientific studies have shown Mangiferin's antioxidant, anti-inflammatory and anticancer properties. (SEE PAGE 2)
