# **'Official leaks' to** target KCR backfires

# Evidence proves the then BRS govt signed PPA with C'garh

### STATE BUREAU HYDERABAD

An attempt by the Congress government to target Leader of Opposition and BRS president K Chandrashekhar Rao through planned media leaks alleg-ing that there was no formal Power Purchase Agreement (PPA) with Chhattisgarh by the previous BRS government and that the State Electricity Regulatory Commis-sion had not ratified the PPA, is backfiring, with documentary evidence proving the 'official leaks' to be false.

The media leaks were engineered on Monday through multiple sources in the media itself in the garb of "statements from officials", with some sections of vernacular media stating that there was no formal PPA and that the ERC had not ratified the PPA, while some others, based on such leaks, wrote that the PPA had resulted in losses to the tune of Rs 6,000 crore to the

Those were the days. Power outages at the slightest of the rain or during hot and humid summer have become the unsettling reality in Hyderabad lately. And frustrated citizens in Hyderabad are increasingly taking to social media to voice their discontent, with many recalling the era of the BRS government fondly when such power cuts were unheard of.

Heavy rains on Monday exacerbated the situation, causing widespread power outages across Hyderabad and sparking frustration among residents. Tagging Chief Minister A Revanth Reddy and Energy Minister Mallu Bhatti Vikramarka in numerous social media posts, citizens questioned the ability of the Congress government to manage the power infrastructure developed by the previous BRS administration.

The recent spate of outages has many longing for those "good old days" when the city's power supply was more reliable. A user on the X lamented, "Thank you @INCTelangana for bringing back dark days. It's such a shame that the infrastructure set up by the previous govt has been destroyed. There was no power for nearly 30 minutes at 3 am and now again there is a power cut here in the heart of Hyderabad." Another post read, "10 years of BRS rule and no power cut in Hyderabad. 'Censorship' on social media

HYDERABAD: Amid the outcry, several allegations surfaced online claiming that complaints about power cuts were being forced to be deleted. Numerous X users accused of ficials of visiting homes and compelling individuals to delete their tweets, citing government pressure.

"After complaining that there had been a power cut, a few people from the electrical team came home to make me delete the tweets citing pressure from the government. What kind of government is this? (sic)," lamented a user named Krithika. Responding to the tweet, BRS working president KT Rama Rao criticised the Energy Department and Telangana Southern Power **Distribution Company** Limited (TGSPDCL) for

intimidating citizens who voiced concerns for better services. In a tweet, he said, "Nincompoops who

can't solve basic issues are frightened when people start questioning them ... ' (SEE PAGE 2)

there were no such problems. The temperature is breaking all records and so are the power cuts. It's very sad to see such poor governance. It feels like we've gone back in time by ten years. These long and frequent power cuts are terrible," said a resident. A similar sentiment was echoed by another post on X which criticised the ongoing situation as the "new norm" for Hyderabad.

# Govt misses deadline again, this time in appointing V-Cs

The Congress government has failed to meet its own deadline of appointing regular Vice-Chancellors (V-Cs) to ten State universities. While recently appointing bureaucrats as in-charge Vice-Chancellors, the government had decided to appoint regular V-Cs by June 15. For instance, the government orders for Osmania University, issued on May 21, appointed MA&UD Department Principal Secretary M Dana Kishore as incharge Vice-Chancellor with immediate effect till the regular V-C is appointed, or till June 15, 2024, whichever is earlier.

Like the other nine universities, not much has progressed since then, though

in terms of technicality, Dana Kishore's term as OU in charge V-C is over since the mentioned date happened to be June 15.

Chief Minister A Revanth Reddy is learnt to have directed Education Department officials to select regular V-Cs before the tenure of outgoing V-Cs ended on May 21. However, the process for regular V-Cs selection appears to have remained on the back burner despite forming the mandatory university-wise search panels on May 15. Each search committee comprises one nominee each from the State government, the University Grants Commission and the respective university's executive council. According to sources, while the search panels were formed on May 15, the information was communicated to the committee nominees in the last week of May.

"The order copy has mentioned that the search committee meeting will be scheduled shortly. So far, there has been no progress on the meeting nor, the government has asked for dates for such a meeting. I have no idea why there is a delay in holding the meeting," one of the nominees of a search panel told 'Telangana Today'. (SEE PAGE 2)

# Jilted lover bludgeons woman to death in Maha

PALGHAR: A jilted lover struck 18 blows on the head of his girlfriend on a road in Vasai on Friday, even as scores of people watched the gory spectacle, police said. "The accused attacked the woman with an industrial spanner. There were 18 wounds on her body," senior inspector Jairaj Ranawre of Valiv police station said. The man, Rohit Yadav (32) and the woman Arati Yadav (22) were neighbours and in a relationship for the last few years, police said.
