BRS sees move to privatise SCCL

Savs Cong. BJP going for auction of coal blocks

The BRS on Thursday voiced its opposition to attempts of the BJP and Congress to 'weaken' the Singareni Collieries Company Limited (SCCL) by depriving it of direct allocation of coal mines.

Bharat Rashtra Samithi (BRS) working president KT Rama Rao, addressing a press conference here, said the BJP-led Centre and Congress-led State government were conspiring to deprive the SCCL of coal mines so that the company would find itself on a weak foot, run into losses and, later, be pushed into private hands.

He found fault with the State government for opting to participate in the coal mine auctions instead of seeking direct allocation of coal mines to Singareni.

The Centre is auctioning more than 60 mines across the country, including coal blocks pertaining to Singareni, from Friday. The State government's partici-

ALL-PARTY DELEGATION TO MEET KISHAN

KHAMMAM: An all-party delegation will meet Union Coal and Mines Minister G Kishan Reddy seeking to allot coal blocks in Telangana to the SCCL, Deputy Chief Minister Mallu Bhatti Vikramarka said on Thursday. He said Kishan Reddy will launch the 10th round of commercial coal mines auction in Hyderabad on Friday. On behalf of the State government, the Union Minister would be requested to allot the Sravanapalli coal block in Mancherial district, which goes under the hammer in a couple of months, to SCCL without auction. Bhatti Vikramarka said Kishan Reddy would be asked to seek Prime Minister Narendra Modi's appointment to consult him regarding the issue. An all-party delegation and stakeholders would request the Prime Minister to protect the interests of the SCCL.

pation in the auction contradicts its previous stance of opposing the auction and seeking direct allocation from the Centre to Singareni, Rama Rao said, pointing out several instances where coal mines were allocated without bidding to entities in other States, but not to Singareni.

In 2015, he said two mines in Odisha were given to Nevveli Lignite Corporation. Similarly, four coal mines were allocated to public sector companies in Gujarat without bidding. BJP's Tamil Nadu president

lobbied to exclude coal mines in his State from auction, he said. "But the Visakhapatnam Steel Plant's plea for the Bailadila coal mine in Chhattisgarh was ignored. Without a dedicated coal mine, the company was pushed into losses and attempts were made for its privatisation," he said, cautioning that a similar strategy was being applied to Singareni, aiming to force it into losses by denying it coal mine allocations, ultimately pushing it towards privatisation.

Pradhan says UGC-NET cancelled as paper leaked on Darknet

Amid demand by the Opposition to re-conduct medical entrance exam NEET, Education Minister Dharmendra Pradhan on Thursday said isolated incidents of malpractice should not affect lakhs of students who cleared the examination rightfully.

He announced a highlevel panel to look into the functioning of the testing agency NTA. Addressing a press conference here, Pradhan also appealed to the opposition parties not to politicise the issue and said strict action would be taken against those found guilty, including officials from the National Testing Agency.

On the cancellation of the UGC-NET examination for the selection of junior research fellows, assistant professors and PhD scholars, the Union Minister said the exam paper was leaked on Darknet.

Kejriwal gets bail in excise case

In a huge relief to Delhi Chief Minister Arvind Kejriwal, a court here on Thursday granted him bail in a money laundering case stemming from the alleged excise scam.

Special Judge Niyay Bindu declined the ED's prayer to keep in abeyance the bail order for 48 hours to allow the central agency to appeal against it in a superior court. The judge ordered Kejriwal's release on a personal bond of Rs 1

SC SEEKS CENTRE, NTA'S RESPONSE ON PLEAS FOR CANCELLING NEET-UG 2024

NEW DELHI: The Supreme Court on Thursday sought responses from seeking scrapping of the NEET-UG 2024 exam and a court-monitored probe, amid mounting outrage over alleged irregularities in conducting the all-India medical entrance test. The apex court also stayed further proceedings on similar pleas pending before different High Courts. The top court, however, made it clear that it would not stay the counselling process. A Vacation Bench of Justices Vikram Nath and SVN Bhatti is sued notices to the parties seeking their responses on four separate pleas filed by the NTA seeking the transfer of pending petitions. PTI

Woman tortured for not 34 die in TN showing up at work

In a gut-wrenching incident, a 30-year-old Chenchu tribal woman was assaulted by three persons after she failed to turn up for work after taking advance payment, at Molachintalapally village in Kollapur mandal in the district.

The accused disrobed her, tied her to a tree, burnt her private parts and rubbed chilli powder into her eyes, with the brutal torture going on for nearly a week. The incident came to light on Wednesday night when locals approached police, who rescued her from the trio.

According to police, K Eddanna and K Eshwaramma used to work as labourers after taking money in advance from people. The couple agreed to work for one Bandi Venkatesh and took the money, but Eshwaramma did not turn up after working for a few days.
