# Says Anumula brothers destroying lives of poor in Telangana

#### STATE BUREAU HYDERABAD

Hauling Chief Minister A Revanth Reddy over the coals for pushing the poor out onto the streets by demolishing their homes while protecting his own brother from the law, BRS working president KT Rama Rao on Tuesday said the Anumula brothers were destroying the lives of the poor in Telangana under the guise of HYDRAA operations.

In an unprecedented scathing attack on the Congress-led State government, Rama Rao singled out Revanth Reddy's brother, A Tirupathi Reddy, for receiving preferential treatment and being served with a 30day notice, enabling the latter to approach the court and get stay orders. The poor, meanwhile, lost their homes within hours.

"Vedashree, an LKG student, wasn't even given time to collect her books before her house was de-molished. A 50-year-old woman, Kasturi Bai, lost her only source of livelihood — a small shoe repair shop — due to these heart-

# Telangana likely to witness heavy rains over next 48 hrs

The Indian Meteorological Department (IMD)-Hyderabad issued a heavy rainfall alert for almost all districts across the State for the next 48 hours, even as intense thunderstorms lashed Hyderabad and districts on Tuesday.

In its 48-hour forecast, the IMD-H predicted heavy rainfall for Hyderabad, Rangareddy, Medchal-Malkaigiri, Vikarabad, Sangareddy, Medak, Kumuram Bheem Asifabad, Mancherial, Nirmal, Nizamabad, Bhadradri Kothagudem, Khammam, Nalgonda, Suryapet, Kamareddy, Mahabubnagar, Nagarkurnool, Wanaparthy, Narayanpet and Jogulamba Gadwal.

Govt allocates **BRAOU** land to JNAFAU CITY BUREAU

Despite strong opposition from teaching and non-teaching staff of Dr BR Ambedkar Open University (BRAOU), the government issued orders allocating 10 acres of the varsity land in Jubilee Hills to Jawaharlal Nehru Architecture and Fine Arts University (JNAFAU).

The Higher Education Department sent letters on September 19, allocating 10 acres to the Registrars of BRAOU both and JNAFAU. The news of the allocation became public on Tuesday. # Double whammy for Khammam ryots

The farmers in the district are in trouble after the recent rains and flash floods destroyed much of their standing crops. That's not all. They are facing another problem in form of sand deposits in agricultural fields. A large extent of agricultural lands on the banks of Munneru, Akeru and Palair

streams in the district were damaged due to huge quantities of sand deposited in the fields. It is causing problems to farmers on two counts — firstly, they lost standing crops, and sec-ondly, the soil structure has been altered.

Many farmers are worried that it might take them at least two or three years to recover from the losses. Speaking to 'Telangana

Today', CPM's Telangana Rythu Sangham leader Bhukya Veerabharam said that a farmer has to spend approximately Rs 2 lakh to clear sand deposits and restore the land to its original form. However, the Central team that recently toured flood-affected areas reportedly told the farmers that

there is no provision to compensate for the loss caused by sand deposits. As many as 2,700 acres have been affected by sand deposits across the district, he said. Farmers are in dire straits as they could not find any means to pay the debts they took to invest in farming and to pay fee for their chil-

dren's education among others. Farmers are yet to receive compensation of Rs 10,000 per acre announced by the State government. The State and Central governments should immediately provide proper compensation and provide assistance, he demanded.

A farmer, Avireni Veerabhadram, said he cultivated paddy and chilli in two acres each and cotton in one acre by investing around Rs 6 lakh. Sand has been accumulated in four acres, thereby fully damaging the crops, he lamented. Similarly, other farmers, Gaddam Narayana and Vuribandi Chandraiah, said that they lost crops in Akeru floods, including irrigation pump sets. The Central team visited the fields 20 days ago, but the promised assistance is yet to be provided, they complained.
