MUSI SURVEY TRIGGERS STIR

Families from Langar Houz, Asad Baba Nagar, New Maruti Nagar Colony refuse to give up their homes

CITY BUREAU HYDERABAD

The markings left behind by revenue officials on their dwelling units are seen by these poor families as the ones that change their fate line and uproot their lives.

Faced with an uncertain future and anguished at the prospect of bulldozer metal blades displacing their lives, scores of families from dwelling units in areas around the Musi river took to the streets here on Friday. As the administration began marking houses, said to be located in the riverbed, for demolition squads to run through for the Musi Riverfront Development Project, affected families the protested at Langar Houz, Asad Baba Nagar, New Maruti Nagar Colony and other areas. Protestors also flocked the Amberpet tehsildar's office demanding that the government roll back the decision of evicting 80 workshops in Durgana-

gar Basti. They alleged that officials pasted stickers on the workshops, marking them for demolition, and lamented that the livelihoods of hundreds of families depended on these small karkhanas. Anusha alleged that her husband was summoned by Devender on September 22 for questioning. The SI allegedly tortured Ashok and forced him to confess to the crime. ED raid on Ponguleti

HYDERABAD

The Enforcement Directorate (ED) was conducting searches on Friday at the premises of Revenue Minister Ponguleti Srinivas Reddy and son P Harsha Reddy in a case of alleged money laundering.

Simultaneous searches were carried out at the Minister's residence at Jubilee Hills in Hyderabad, his farmhouse at Himavat Sagar on the city outskirts and other premises related to his son, daughter and other family members.

The searches were also conducted at the premises of a construction firm owned by Harsha Reddy and other places in their home district Khammam.

Sixteen teams were conducting simultaneous searches at the houses, offices and other premises.

The searches were related to a case of money laundering, which has been registered based on a complaint from the Directorate of Revenue Intelligence (DRI) against Harsha Reddy for allegedly purchasing seven expensive watches worth Rs 7 crore.

Harsha, who is into the construction business, was issued a summons by the Customs Department in connection with the purchase of two luxury watches worth Rs 1.73 crore allegedly smuggled from Hong Kong via Singapore, according to the probe agency. (SEE PAGE 2)
