Ex-BRS MLA arrested for Lagacherla row

Cops drag Patnam Narender Reddy out of his home

Dramatic developments were witnessed in the State capital on Wednesday, beginning from Hyderabad before shifting to Parigi, when policemen in mufti dragged former Kodangal MLA Patnam Narender Reddy of the BRS from his Film Nagar residence around 6 am and bundled him into a vehicle even as he resisted, asking them who they were.

It was only much later that it came to light that he was arrested by the Vikarabad police in connection with the attack on gov-ernment officials at Lagacherla village of Dudyal mandal in Kodangal constituency two days ago. After several hours of questioning at the Parigi police station, Narender Reddy was produced before court, where he was remanded in judicial custody for 14 days and shifted to prison.

The arrest was in connection with Monday's attack on Vikarabad Collector Prateek Jain, Kodangal Area Development Authority special officer Venkat

Reddy and other officials, who had visited Lagacherla in Kodangal, Chief Minister A Revanth Reddy's constituency, to seek opinion on land acquisition from the public for the Pharma Village project.

The villagers had turned angry alleging that they were being forced to part with their fertile land, and attacked the officials. The police version is that one B Suresh, a follower of Narender Reddy, instigated the villagers to attack the officials, allegedly at the instance of the former MLA. Sources said the police arrested Narender Reddy based on his multiple phone calls with Suresh before and

Condemning the arrest, BRS working president KT Rama Rao and other senior leaders demanded for his immediate release. They called the arrest an undemocratic act by the Congress government as part of its bid to blame the BRS for the unrest in Revanth Reddy's constituency. (SEE PAGE 2) (RELATED REPORTS PAGE 5)

Lays down norms for demolition of properties

Equating 'bulldozer justice' with a lawless state of affairs where might is right, the Supreme Court on Wednesday laid down pan-India guidelines and said no property should be demolished without show-cause notice and the affected must be given 15 days to respond.

The executive cannot assume judicial powers to punish citizens by demolishing their properties without following due process, it said while terming such excesses "high-handed and arbitrary" and ruling that they need to be dealt with the "heavy hand of the law".

A Bench of Justices BR

Gavai and KV Viswanathan described as "chilling" the sight of a bulldozer demolishing a building, rendering women, children and aged persons homeless overnight. "If the executive acts as a judge and inflicts penalty of demolition on a citizen on the ground that he is an accused, it violates the principle of 'separation of powers'," the Bench said in its 95-page judgment. THE VERDICT

Here are the highlights of the Supreme Court's verdict laying down pan-India guidelines on demolition of properties

- Executive cannot become judge, decide that person accused is guilty and punish him by demolishing his property
- No demolition should be carried out without prior show-cause notice
- Notice shall be served upon owner/occupier by registered post, it shall be affixed conspicuously on outer portion of structure in question
- If statute provides for appellate opportunity and time for filing same or even if it does not so, order will not be implemented for 15 days from date of receipt thereof

principles of natural justice and have acted without adhering to the principle of due process, reminds one of a lawless state of affairs, where 'might was right'," it said. It said high-handed and arbitrary actions have no place in the Constitution, which rests on the foundation of the rule of law.

The Bench made clear that they will not be applicable if there is an unauthorised structure in a public

footpath, abutting railway line or river or water body and also in cases where there is an order for demolition made by a court of law. "No demolition should be carried out without prior show cause notice returnable in accordance with time provided by municipal laws or in 15 days from date of service of notice, whichever is later," it said. 'Revanth misusing power to further family business'

Holding Chief Minister A kevanth Reddy responsible for the Lagacherla attack on officials, BRS working president KT Rama Rao targeted the former for orchestrating large-scale land acquisition under the guise of promoting the pharma sector.

He also charged the Chief Minister with misusing official machinery to serve his family business interests, without considering its impact on the lives of farmers as well as villages.

He suspected that the Chief Minister orchestrated the attack to create a law and order problem, before acquiring the land without conducting a legitimate public hearing. He de-

Speaking to mediapersons at Telagana Bhavan on Wednesday, Rama Rao said land belonging to marginalised communities, including SCs, STs and BCs, was being forcibly acquired for private companies linked to the Chief Minister's family. He specifically targeted the

expansion of Maxbien Pharma, which is owned by Revanth Reddy's son-in-law G Satyanarayana Reddy. He iestionea tne Medicover Hospital owner and Satyanarayana Reddy's partner Annam Sarath in the issue. "Farmlands are being ac-

quired in Kodangal to benefit Revanth Reddy's family, while the poor farmers are left to suffer," he said, adding that the land acquisition in Lagacherla and surrounding areas was not for public good, but an outright real estate deal to benefit Revanth Reddy's family members. The government was misusing official power to intimidate farmers and acquire land forcibly for the private pharma company.

Engineering management quota fee to triple? Telangana Council of twice the fee set for the con-

Engineering aspirants eyeing for a management quota seat in private colleges may have to shell out triple the fee set for the convener quota from next year. For instance, if a convener quota seat in a private engineering college costs Rs 1 lakh per annum, the management seat will be Rs 3 lakh.

The move, which could impact thousands of students, comes as part of the

Education's Higher (TGCHE) efforts to streamline the management quota admission process in private engineering colleges.
The TGCHE plans to take

over the engineering management quota admissions from the next academic year, aiming to increase transparency and fairness in the admission process. Permission to implement online admissions for the management quota, besides tripling the fee, will be shortly

sought from the State government. According to senior TGCHE officials, the engineering management admissions are

being planned on the similar lines of the MBBS and BDS management quota seats via merit secured in NEET UG.

Medicine and dental seats in private medical and dental institutions are being filled by the Kaloji Narayana Rao University of Health Sciences through web-based counselling. Here, the management quota fee is up to

vener quota seat. Similarly, the category C (NRI) seats fee is up to twice the fee of the management quota seat. Currently, 70 per cent of

the seats in private engineering colleges are filled via the Telangana Engineering, Agriculture and Medical Common Entrance Test (TG EAPCET) by the TGCHE. The remaining 30 per cent of the seats are filled by the colleges' management by advertising in newspapers. As per the

rules, managements have to follow the order of merit. starting with NRI candi-JEE Main, TG **EAPCET** and Intermediate scores not less than 45 per cent. But so far, these rules are only on paper. Only a few colleges adhere to the rules. There has been long distance demand from different student organisations to regulate management quota seats in private engineering colleges, which have been charging exorbitant fees from students.
