#### MDMA seized, 2 peddlers arrested

#### 10 killed in Nigeria **Xmas stampede**

ABUJA: Ten people, including four children, have been killed in a stampede in Nigeria's capital city as a large crowd gathered to collect food items distributed by a local church at a Christmas event, police said on Saturday. The stampede occurred in the early morning hours at the **Holy Trinity Catholic** Church in Maitama, an upmarket part of Abuja, police spokesman Josephine Adeh said, adding that more than 1,000 people have been evacuated from the

### Revanth admits lack of funds to implement guarantees

HYDERABAD

Chief Minister A Revanth Reddy on Saturday admitted that the State government was unable to implement the six guarantees and other promises, including Rythu Bharosa, due to financial constraints.

Blaming the previous BRS government for his government's inability and delay in the implementation of the six guarantees and other election promises of the Congress, he said if the State government was facing challenges to implement Rythu Bharosa, extend financial assistance to tenant farmers, monthly allowance to women and one tola gold as part of Kalyana Lakshmi, the previous government should be held responsible.

Speaking during a short discussion on Rythu Bharosa in the Assembly, the Chief Minister claimed that all the income generated and loans raised by the State government were being used to pay the interest and principal component of loans raised by BRS government in the past.

"If this burden of repaying the past government's loans was not imposed on us, I would have done wonders in Telangana," he claimed, saying that the State

government would have offered MSP for all crops, paid Arogyasri bills one month in advance, offered Rythu Bharosa and cleared farmers loans completely if there were no financial issues.

Admitting that he was visiting New Delhi frequently, the Chief Minister said financial experts were consulted to get the loans restructured. If there was any reduction in the interest component on the loans, it would aid in considerable savings for the

### KTR tears into Congress for failing to fulfil promises

HYDERABAD

Launching a scathing attack on the Congress government for the yawning gap between its words and deeds in the implementation of the loan waiver, BRS working president KT Rama Rao said Chief Minister A Revanth Reddy was misleading the public and the Assembly with false statements on the extent of debt relief extended to the farmers.

Stating that Revanth Reddy had come out with a confession statement admitting his inability to implement the six guarantees promised by the Congress to win the polls, he pointed out that the Chief Minister was unable to explain how the promised Rs 49,500-crore loan waiver was reduced to Rs 26,000 crore. Despite this, Revanth Reddy had shamelessly claimed that 100 per cent of the loan waiver had been

implemented.
The BRS leader criticised the Congress government for making false promises during elec-tions and failing to deliver once in power. He accused the Congress of misleading farmers with promises of loan waivers and then failing to implement them effectively. He pointed out that the previous BRS government

had significantly reduced farmer suicides in Telangana through initiatives such as Rythu Bandhu and Rythu Bima.

Citing the National Crime Records Bureau data, which showed a decrease in farmer suicides from 1,348 in 2014 to 178 in 2022, he attributed the drop to the BRS government's support for the agricultural sector. He also pointed out that the Congress government had failed to provide a clear explanation for the discrepancies in the loan waiver figures. He said while one

Congress leader claimed that 70 per cent of the loan waiver had been implemented, the Chief Minister claimed that 100 per cent had been achieved. He asserted that no village in the State had received a complete loan waiver and that even the Chief Minister's own village, Kondareddipalle, was no exception.

Rama Rao also said the Congress government had diverted funds from schemes such as Rythu Bandhu to cover the loan waiver and vowed to continue holding the party accountable.

### Public inspection of poll e-records curbed

#### Centre tweaks election rule to limit access to videos

NEW DELH

The government has tweaked an election rule to prevent public inspection of certain electronic documents such as CCTV cameras and webcasting footage, as well as video recordings of candidates, to prevent their misuse.

Based on the recommendation of the Election Commission (EC), the Law Ministry on Friday amended Rule 93(2)(a) of the Conduct of Election Rules, 1961, to restrict the type of "papers" or documents open to public inspection.

According to Rule 93, all "papers" related to elections shall be open to public inspection. The amendment inserts "as specified in these rules" after "papers". The Law Ministry and EC officials explained that a court case was the "trigger" be-

#### Why is ECI afraid of transparency: Cong

**NEW DELHI:** The Congress on Saturday hit out at the Election Commission for tweaking an election rule to prevent public inspection of certain electronic documents such as CCTV camera and webcasting footage, asking why the poll panel was afraid of transparency.

Congress general secretary in-charge communications Jairam Ramesh said the party would legally challenge amendment. "If there was ever a vindication of our assertions regarding the rapidly eroding integrity of the electoral process managed by the Election Commission of India (ECI) in recent times, this is it," Ramesh said in a post on X. Sharing a December 20 notification, the Congress leader said, "This move of the ECI will be challenged legally right away." PTI

#### Seven Indians injured in German Christmas market attack

Seven Indians have been injured in the deadly carramming attack in the east ern German city of Magdeburg and the Indian embassy in Berlin is providing them all possible assistance, official sources said on Saturday night.

A 50-year-old man drove his car into crowds at a Christmas market on Friday evening in Saxony-Anhalt State's Magdeburg, leaving at least five people, including a nine-year-old, dead and nearly 200 injured, authorities said. Three of seven injured Indians have been discharged from hospital, the sources cited above said.

The Ministry of External Affairs, condemning the "horrific and senseless" attack, said the Indian mission in Germany is in contact with Indians injured. It, however, did not specify the number of injured Indians. PTI (REPORT PAGE 9)

## Panic over fire in IT corridor

Panic prevailed in the city's IT corridor at Madhapur in the early hours of Saturday after a fire broke out at the attva Elixir building inside Knowledge City, Madhapur. No casualties were reported in the incident.

According to the fire officials, the incident was reported to the control room at 6.12 am and fire tenders rushed to the spot within a short time. Fire was noticed on the fourth floor and firefighting operations were reinforced with a Bronto Skylift and additional fire tenders from Gachibowli, Vattinagulapally and Kukatpally fire stations.

The mishap occurred in the ground plus four-storey building that houses restaurants, a bar and a gymnasium. It took over an hour for the officials to control the blaze.

Fire officials said the fire started on the fourth floor and spread to the other floors. "The cause of the fire is being ascertained," Shaik
