Telugu man dies in paragliding mishap

MANALI: A tourist from Andhra Pradesh died in a paragliding accident in Himachal Pradesh's Kullu district. Godavari-Banakacherla project triggers fears of Telangana again losing share of water

STATE BUREAU HYDERABAD:

The Godavari-Banakacherla project could raise riparian concerns right at the proposal stage as it is feared to affect not only Telangana, but other regions as well. The project is expected to have serious ramifications, but its realisation depends on the perspective and approach of the Krishna Water Disputes Tribunal-2, headed by Justice Brijesh Kumar.

Proposed with an estimated cost of Rs.80,122 crore, it seeks to address the water woes in the Krishna basin using Godavari waters. According to river water experts, it is going to be yet another pandora's box being opened by Andhra Pradesh, adding to the conflict situation over water sharing with any water drawn from the Godavari to replenish the Krishna basin likely to result in a genuine entitlement for all the riparian States involved.

The Congress government in the State had already approached the Godavari River Management Board (GRMB) for detailed information about the project proposed by the Andhra Pradesh government. However, the GRMB is still in the dark about the new project and it will take at least three months for the AP government to prepare the De-

tailed Project Report (DPR). Once the DPR is presented to the Godavari board and the Central Water Commission (CWC), the process of looking into the concerns of the upper riparian States

CWC SEEKS INFO ON PROJECT

The Central Water Commission (CWC) on Wednesday requested for detailed information regarding the proposed Godavari-Banakacharla linkage project announced by Andhra Pradesh. The CWC's letter, sent to the river management boards of the Godavari and Krishna, as well as the Polavaram Project Authority, has brought to the fore key issues involving Godavari water sharing. The project, with an estimated cost of Rs 85,000 crore, aims at diverting 2 TMC of water from the Godavari river at the Polavaram project. This water is intended to address both drinking water and irrigation needs in the Rayalaseema region and the coastal districts of Nellore and Prakasam in Andhra Pradesh

6 killed in Tirupati stampede

Incident occurs during sale of Vaikunta Dwara Darshan tickets

TIRUPATI

Six devotees, including three women, died and several more were injured in a stampede here on Wednesday night as hundreds of them jostled for tickets for Vaikunta Dwara Darshanam at Lord Venkateswara Swamy temple on Tirumala Hills, a police official said.

Hundreds of devotees turned up from across the country for the 10-day Vaikunta Dwara Darshanam commencing from January 10. "Three women and a man, among others, died in the stampede," the official said. Meanwhile, videos of police administering CPR on a couple of women devotees and injured persons being shifted in ambulances went viral.

Woman, daughter run over by truck

A woman and her daughter were killed, while her husband is fighting for his life in a hospital, after their motorcycle was hit by a truck on the city outskirts on Wednesday.

Tragedy struck the family when the rashly driven truck hit the motorcycle, which the trio was riding, at Tukkuguda in Pahadishareef. Ch Gopal (36), his wife Lakshmamma (33) and their daughter Vijaya (14), a Class VIII student, all from

According to the police, when the trio reached Tukkuguda road near the Outer Ring Road (ORR), a rashly driven truck hit the motorcycle. As a result, the family fell on the road and suffered grievous bleeding

Kingfisher beer lovers are in for a heart break in Telangana. Manufacturer United Breweries has decided to suspend supply of all brands of Kingfisher beer with immediate effect to the Telangana Beverages Corporation Ltd (TGBCL) due to what it termed as 'significant and ongoing operating

The beer maker maintained that despite continuous efforts over the last two vears, there was no increase of the base prices offered to its products. "This has resulted in escalating losses, making our operations in



the State unviable," the company said. United Breweries makes the popular brands of Kingfisher, Kingfisher Strong, Kingfisher Ultra, Kingfisher UltraMax and some other beer

brands which are hot-selling alcoholic beverage products in Telangana. Kingfisher beer brands account for 60-70 per cent of the total beer sales in the State, industry sources say.

'RS 658 CR DUES TO UB GROUP' **HYDERABAD:** Excise Min-

ister Jupally Krishna Rao admitted that the Telangana government owes Rs 658.95 crore to United Breweries (UB) Limited. He accused UB of halting supplies and pressuring the government to approve a 33.1 per cent price hike, citing rising input costs.
