India, Chile hold trade talks

New Delhi: India and Chile on Tuesday announced starting negotiations on a comprehensive economic partnership pact as Prime Minister Narendra Modi and Chilean President Gabriel Boric Font held wide-ranging talks focusing on boosting the ties in areas of trade, defence, critical minerals and health. Describing Chile as an important "friend and partner" for India in Latin America, Modi said several new initiatives were identified to enhance overall cooperation.

Businessman duped of Rs 1 crore

Hyderabad: A citybased businessman was cheated by cyber fraudsters to the tune of Rs 1.28 crore who allegedly promised automobile dealership of a leading car manufacturer, using a fake website. The fraudsters made the victim transfer the money within ten days under the pretext of registration, security deposit, no-objection certificate, etc., promising to provide a Kia Motors dealership. India sends relief to Myanmar

New Delhi: Bolstering India's efforts to provide succour to quake-hit Myanmar, INS Gharial loaded with relief material weighing nearly 440 tonne, on Tuesday sailed out of Visakhapatnam harbour while a field hospital set up by the Indian Army in Mandalay has been operationalised, offering medical care to the injured. Govt on backfoot as support pours in from across nation for UoH protest

Even as support from the student community across the nation poured in for the University of Hyderabad (UoH) students' protest against the Congress government's move to auction 400 acres of forested land in Kanche Gachibowli, apart from celebrities also extending solidarity, the Congress government tried to wriggle out of the major embarrassment it had landed itself in by slinging mud in all directions.

That the State government was finding itself on the backfoot was evident from the hurried meeting that Chief Minister A Revanth Reddy called for at the Police Command Control Centre nere with a few Cab. inet ministers including Deputy Chief Minister Mallu Bhatti Vikramarka

Writ plea against auction: High

On the other hand, the Students Union, along with several other students' organisations, called for an indefinite protest, commencing Tuesday. The ABVP UoH unit called for a maha dharna at the university main gate even as a large number of police stood put at the university east campus and main gates. Students from various universities also backed the UoH students.

Revanth holds meet on land issue

Slated to fly to New Delhi to brief AICC leadership

With the University of Hyderabad land issue snowballing into a major controversy, Chief Minister A Revanth Reddy held an emergency meeting with a few cabinet Ministers at the Command Control Centre here on Tuesday.

The Ministers were informed about the meeting at short notice. Initially, many thought the meeting would be about cabinet expansion but the discussion was mostly about the University of Hyderabad land issue. Cutting across party lines, political parties are raising objections over the proposed auction of university lands at Kancha Gachibowli. Accordingly, affiliated organizations of a couple of parties organized different programmes in protest against the government's plans.

In this context, the Chief Minister is learnt to have discussed a few aspects with his cabinet colleagues. The focus was on how to counter the opposition parties' narrative and win people's confidence over the issue, sources said. The Chief Minister is also learnt to have issued a few specific instructions to a couple of his cabinet colleagues. Already, the Chief Minister's Office has issued a detailed statement on the university land issue on Monday.

With the Chief Minister slated to fly to New Delhi later this evening, he is expected to brief the AICC

18 killed in blast at cracker warehouse in Gujarat

PALANPUR (GUJARAT)

Eighteen persons were killed and five others injured after a blast at a firecracker warehouse led to a blaze and collapse of the building in Gujarat's Banaskantha district on Tuesday, officials said.

The incident took place in an industrial area near Deesa town at around 9.45

"As many as 18 persons died in the incident, and five others are injured after the slab of the building collapsed following a massive blast," Superintendent of Police Akshayraj Makwana

He said the victims were workers from Madhya Pradesh and their family members, and most of them died after the slab collapsed on them.

The unit was meant to store firecrackers, and so far no clue has been found that firecrackers were being manufactured, Makwana said. Earlier, officials had said it was a factory.

Chief Minister Bhupendra Patel expressed grief over the incident and announced a financial assistance of Rs 4 lakh to the families of the deceased and Rs 50,000 to the injured per-

"The incident of the death of workers due to fire and slab collapse in a firecracker godown in Deesa is heartbreaking. My heartfelt condolences are with the relatives of the deceased in this hour of grief," Patel said in a post on X. "I am in constant touch with the administration regarding the relief, rescue and treatment work in this accident. I have instructed the administration to ensure that the injured get proper treatment at the earliest." PTI

Waqf Bill in Lok Sabha today

New Delhi

The Lok Sabha will take up the contentious Waqf (Amendment) Bill for discussion and passage on Wednesday, setting the stage for a showdown between a government determined to push it through and an opposition united in condemning the proposed law as unconstitutional.

Rajya Sabha is expected to take it up on Thursday, with the two Houses allocated eight hours each for debating the proposed law.

Some BJP allies, sources said, continue to push for more changes in the Bill. A senior member of a BJP ally expressed hope that the saf-



fron party will accommodate their views, stressing that some of their concerns were addressed by the Joint Committee of Parliament

which scrutinised the Bill. TDP and JD(U), the two biggest constituents of the NDA after the BJP, issued whips to their MPs asking them to support the government stand.

The opposition I.N.D.I.A. bloc also presented a united face as its parties discussed their joint strategy to oppose the Bill at a meeting in the Parliament House.

Minorities and Parliamentary Affairs Minister Kiren Rijiju told reporters that the Lok Sabha's business advisory committee (BAC), agreed on an eighthour debate, which could be extended.

The early signs of a raucous debate over the Bill were visible during the meeting as Congress and several other opposition members walked out of the meeting, accusing the government of stifling their (SEE PAGES 2, 7)

Calling the demolition of houses in Prayagraj "inhuman and illegal", the Supreme Court on Tuesday ordered the city develop-ment authority to pay Rs 10 lakh compensation to each aggrieved house owner within six weeks.

"The manner in which the demolition has taken place shocks our conscience. Residences of the appellants have been high-handedly demolished. There is something called right to shelter. due process of law," said a bench of Justices Abhay S

Oka and Ujjal Bhuyan. The bench said the "high handed" manner of the dem-



olitions showed insensitivity on the part of authority while underlining the "rule of the law in the country".

Residential structures of citizens cannot be demolished in such fashion, it added.

The apex court said the

Prayagraj Development Authority must remember right to shelter is an integral part of Article 21 and there is a rule of law which is basic part of the Constitution.

The top court said the demolition was carried out by the authority under Section 27 of the UP Urban Planning and Development Act, 1973.

The bench observed a show cause notice was issued on December 18, 2020, and pasted on the houses the same day, with the remark that on two occasions attempts had been made to

serve it in person. The court said a subsequent order of demolition was also affixed on January 8, 2021, but not sent by the registered post. "The first registered post

communication was sent on March 1, 2021, received on March 6, 2021, and the demolition was carried out the next day, leaving the appellants with no opportunity to appeal under Section 27(2) of the Act," the bench said.

The top court went on, "The object of the proviso to Section 27(1) is to provide a reasonable opportunity to showcause before demolition. This is no way of granting a reasonable opportunity." As per provisions, the bench said, genuine efforts should be made to serve notice in person before resorting to affixture. (SEE PAGE 2)
